#### Call to Order

## **Consideration of Agenda**

The first matter of business was consideration of approval of the agenda for the August 21, 2014, meeting of the Board of Education. It was moved by Mr. Whitt that the agenda be approved as presented. The vote was 6 yes—0 no—1 absent (Mr. Preis was not physically present).

## Tax Rate Hearing and Consideration of School District Tax Levy

Ms. Quinley presented an overview of the process used to determine the proposed tax rate for the Columbia School District for the 2014-15 school year. It was recommended that the tax rate for 2014-15 be established as follows:

Incidental Fund	\$1.8413
Teachers Fund	. 2.6000
Capital Projects Fund	.0736
Total Operating Funds Levy	\$4.5149
Debt Service Fund Levy	.9719
Total Levy	\$5.4868

President King invited public comments on the proposed tax rate. No comments were received.

After discussion, it was moved by Mr. Cushing that the 2014-15 tax rate be established at \$5.4868 as recommended. The vote was 6 yes—0 no—1 absent.

# Consideration of Columbia Public Schools E-mail Accounts for Board of Education Members

President King proposed the administration establish e-mail accounts for Board of Education members. After discussion, it was moved by Ms. Wade that the administration be authorized to establish e-mail accounts for Board of Education members. The vote was 6 yes—0 no—1 absent.

President King presented a Community Improvement District petition for Board consideration. After discussion, it was moved by Mr. Sessions that the petition be approved. The vote was 6 yes—0 no—1 absent.
